PART B: Business items for discussion

7. Chair's Report

The Chair reported that two formal complaints had been received, which were being reviewed and would be responded to within the designated timescales.

Governors RESOLVED that the Chair's report be noted.

8. Head Teacher's Update Report

The Head Teacher provided a comprehensive update report to the Local Governing Body, a copy of which is held on file.

The Head Teacher advised that suspensions and permanent exclusions had increased. Timely interventions, proactive strategies and support continue to be offered to pupils at risk of suspension or permanent exclusion. The staff would continue to ensure the school is a safe and orderly place for all pupils and staff, and that the behaviour of the minority would not have a negative effect on the education, culture or ethos of the academy. Governors questioned what the national picture was with regards to suspensions and permanent exclusions? The Head Teacher advised that there had been a significant increase nationally with regards to behavioral issues. The Chief Executive Officer (CEO) advised that it was a similar picture at a regional level.

It was noted there was an increased need for alternative provision both within the school and in the local authority.

Further to Minute 10 (Longfield Local Governing Body 2nd October 2023) the Head Teacher reported on the Year 11 results and progress for 2022/23. She advised on the progress 8 score which was -0.1 with a banding for Longfield Academy being classed as average. The Head Teacher shared the results of the secondary schools in the town and advised that the progress score was the 2nd highest score in the town; this is incredibly impressive considering it was achieved against the backdrop of the cyber incident in the last academic year. Governors advised that they were good results and wished to pass on their thanks for the hard work of the staff. Governors enquired how best to publicised the positive results. The CEO advised it had been publicised in the Northern Echo and the Academy continued to promote.

The Head Teacher also reported upon the Pupil Premium and Recovery Premium Statement. The statement detailed the school's use of pupil premium funding (and recovery premium for the 2022 to 2023 academic year) to help improve the attainment of disadvantaged pupils. It outlined the pupil premium strategy and how the school intended to spend the funding in the academic year and the effect that last year's spending of pupil premium had within the school. Governors enquired about the negative progress score for Pupil Premium students. The Head Teacher explained that of the 48 PP children, 35 failed to achieve the full suite of 8 subjects which was the biggest impact on the figure. These students had barriers to learning that impacted upon their ability to compete the 8 subjects, however a range of support both pastorally and academically was implemented to ensure that each child had the opportunity to optimize their potential. Governors were informed that all PP children has a case study that documents the aforementioned strategies and support.

Governors **RESOLVED** that the Head Teacher's update report be noted and that the Pupil Premium and Recovery Premium Statement be approved.

He advised the public consultation had commenced and that TUPE (Transfer of Undertakings Protection of Employment) would be launched in January 2024. It was hoped that the institutions would come together as one organisaton as of the 1st April 2024.

13. Special Interest Governors – feedback/updates from school contact

Personal Development – Governor Peter Armstrong advised the governing body that he had been in school today (4th December 2023) and met with the school's improvement partner, to discuss feedback regarding her visit which focused upon personal development in the context of the school's culture and how children respond to their understanding of all aspects of personal development. He advised that the feedback had been positive, with structures and teaching & learning regarding personal development in place. Strategies were also be developed further.

Premises / Health & Safety – Governor Julie Walker advised that she conducted her visit with regards to Premises and Health & Safety. She had spoken to Sarah Jones, Business Manager who had explained her role with regards to premises and health and safety and the role of the external health & safety advisor. The recent audit conducted by the external health & safety adviser was shared with Governor Julie Walker, which had been positive with no concerns raised and all relevant paperwork and processes in place. It was noted Longfield Academy had been

assessed for RAAC in Summer 2023 and none had been found. The Health & Safety Policy was due to be updated in December 2023 and would be reviewed at the meeting of the Local Governing Body scheduled for 11th March 2024.

Finance – In her absence it was reported that Governor Suzi Kirkbride had conducted her visit with regards to finance. The trust has invested into Longfield to help assist with the improvement journey, this included the appointment of a Director of Science, 3 x Teaching Assistants, a new Senco, a new head of behaviour and welfare. Pupil numbers is key to financial stability. It was noted any staff absences contribute to the additional cost of supply.

Behaviour and Attitudes (Attendance & Punctuality, Conduct, Rewards and Sanctions) - Governor Laura Snowdon had conducted her visit with regards to behaviour and attitudes , with no areas of concern identified. A student voice exercise would be undertaken from which Governor Laura Snowdon could triangulate student's views.

Quality of Education (Teaching & Learning, Curriculum and Progress) – Governor Nicola Bales advised she would be in school before the end of term and hoped to conduct another learning walk.
